

Harley-Davidson® - Rolling USA “Daytona” 2022 Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Overview: The “Harley-Davidson® - Rolling USA Daytona 2022” (the “Promotion”) consists of a sweepstakes (the “Sweepstakes”) and a motorcycle prize drawing that will award a motorcycle prize among selected winners of the Sweepstakes (the “Motorcycle Prize Drawing”). **In order to qualify for the Motorcycle Prize, each Grand Prize winner must be present at the Rolling Daytona Bike Giveaway event (“Event”) on or around March 12, 2022 at the Destination Daytona Complex with an address of 637 US-1, Ormond Beach, FL 32174.**

The Sweepstakes: Prior to the start of the Sweepstakes, the Sponsor will provide certified participating Harley-Davidson® dealers (each a “Participating Dealer”) with “codes” (each a “Code”). You will be encouraged to visit a Participating Dealer, participate in various activities to collect Codes, and visit the Website to enter the Code(s) for Sweepstakes entries. In addition, there are “Non-Participating Dealers”. For each time you “check-in” at a Participating Dealer using the H-D App, you will receive two (2) Sweepstakes entries and if you “check-in” at a Non-Participating Dealer using the H-D App, you will receive one (1) Sweepstakes entry. Section 4 also outlines how you may receive Sweepstakes entries without visiting a Participating Dealer location and engaging in the outlined activities.

The Motorcycle Prize Drawing: The Sponsor will award the Motorcycle Prize among the ten (10) Grand Prize winners determined in the Sweepstakes (each a “Motorcycle Prize Drawing Qualifier”; or collectively each a “Qualifier”) for the opportunity to win the Motorcycle Prize. See Section 5 below for complete details.

1. Eligibility: The Sweepstakes is open only to legal residents of Alabama, Connecticut, Florida, Georgia, Illinois, Indiana, Kentucky, Louisiana, Massachusetts, Michigan, Missouri, Mississippi, North Carolina, New York, Ohio, South Carolina, Tennessee, Texas, West Virginia, and Wisconsin who are at least eighteen (18) years old at the time of entry. Employees of Harley-Davidson, Inc. (“Sponsor”), and its Dealers and retailers, affiliates, sales representatives, distributors, and promotional and other vendor agencies, Mighty Loud, Inc., Merkle Inc. (“Administrator”), their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors involved in the promotion, and the immediate family (parent, spouse, including common law spouse, sibling, child, grandparent, grandchild, regardless of where they reside) and household members of all such employees, are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void outside the listed states and where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules. Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstakes begins on January 14, 2022 at 12:00 a.m. Eastern Time (“EST”) and ends on February 19, 2022 at 11:59 p.m. EST (the “Promotion Period”). Administrator’s computer is the official time-keeping device for the Sweepstakes.

The Motorcycle Prize Drawing will occur approximately on or about March 12, 2022. Sponsor’s computer is the official time-keeping device for the Motorcycle Prize Drawing.

4. How to Register and Enter the Sweepstakes:

How to Register: During the Promotion Period, visit www.RollingUSA2022.com ("Website") and follow the links and instructions to complete and submit the registration form including your full name and valid email address. Then, on your first visit only, you will be asked to select your Dealer, from a provided list. You automatically will receive one (1) Sweepstakes entry. Limit: You may receive one (1) Sweepstakes entry during the Promotion Period for registering for the Sweepstakes. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of Sweepstakes entries (as outlined below) by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

How to Receive Sweepstakes Entries: There are multiple ways to earn additional Sweepstakes entries, as outlined below:

All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive two (2) additional entries into the Sweepstakes during the Promotion Period for either making a service appointment **or** sending in a mail-in, as outlined above.

- b) Take a Test Ride: During the Promotion Period, visit Participating Dealer and take a test ride. Once you do so, you will receive a Code. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without taking a test ride at a Participating Dealer, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – Test Ride," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive two (2) additional entries into the Sweepstakes during the Promotion Period for either taking a test ride **or** sending in a mail-in, as outlined above.

- c) JUMPSTART at Dealer: During the Promotion Period, schedule a JUMPSTART Rider Experience with a Participating Dealer offering a JUMPSTART and complete the JUMPSTART experience at the Participating Dealer. Once you do so, you will receive a Code. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries. **The JUMPSTART experience is only available in limited locations.**

To earn additional Sweepstakes entries without jumpstart at Participating Dealer, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – JUMPSTART," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Once you do so, you will receive a Code. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without making a General Merchandise or Parts & Accessories purchase, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – General Merchandise or Parts & Accessories Purchase," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without making a motorcycle purchase, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – Motorcycle Purchase," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2)

additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

To earn additional Sweepstakes entries without engaging in a conversation with a Dealer employee, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – Conversation," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Once you do so, you will receive a Code. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without attending a Dealer event, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Harley-Davidson Rolling USA – Dealer Event," c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. To earn additional Sweepstakes entries without showing your HOG® card, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA – HOG Card,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. To earn additional Sweepstakes entries without participating in a Dealer Ride, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA – Dealer Ride,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. To earn additional Sweepstakes entries without volunteering at a Participating Dealer event, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA – Volunteer,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. - l) Schedule a Safety Inspection of your Motorcycle: During the Promotion Period, schedule a safety inspection of your motorcycle at a Participating Dealer. Once you do so, you will receive a Code. Follow the links and instructions on the Website to enter the Code. Once your Code is validated, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without getting a Safety Inspection, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA – Safety Inspection,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive two (2) additional entries into the Sweepstakes during the Promotion Period for either getting a safety inspection **or** sending in a mail-in, as outlined above.

- m) Check-In at a Participating Dealer using the H-D App: During the Promotion Period, visit your Dealer and open the Harley-Davidson app and follow the links and instructions to “check in”. Once you do so, you will receive two (2) Sweepstakes entries.

To earn additional Sweepstakes entries without checking in, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA – Participating Dealer Check-In,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive two (2) additional Sweepstakes entries. Limit: One (1) request for two (2) additional entries per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive two (2) additional entries into the Sweepstakes per day during the Promotion Period for either checking-in **or** sending in a mail-in, as outlined above.

- n) Check-In at a Non-Participating Dealer using the H-D App: During the Promotion Period, visit your Dealer and open the Harley-Davidson app and follow the links and instructions to “check in”. Once you do so, you will receive one (1) entry into the Sweepstakes.

To earn additional Sweepstakes entries, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Harley-Davidson Rolling USA 2022 – Non-Participating Dealer Check-In,” c/o Merkle Inc., P.O. Box 5022, Department 851212, Kalamazoo, MI 49003-5022. You will receive one (1) additional Sweepstakes entry. Limit: One (1) request for one (1) additional entry per envelope. All mail-in entries must be handwritten and must be postmarked by February 19, 2022 and received by February 25, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive one (1) additional entry into the Sweepstakes per day during the Promotion Period for either checking-in **or** sending in a mail-in, as outlined above.

5. Grand Prize Sweepstakes Drawings and Motorcycle Prize Drawing Winner Determination: Grand Prize Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential Grand Prize winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select each potential Sweepstakes Grand Prize winner from all eligible entries received during the Promotion Period, on or around March 1, 2022. The potential Grand Prize winners will be notified by email. Each potential Grand Prize winner (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator within forty-eight (48) hours of the date notice or attempted notice is sent, in order to claim his/her/their prize.

If a potential winner of any Grand Prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits his/her/their prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable Grand Prize to an alternate winner, time permitting, by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the applicable Grand Prize will remain un-awarded.

Motorcycle Prize Drawing Winner Determination: Each confirmed Sweepstakes Grand Prize winner must be present at the Event or he/she/they forfeits the opportunity for a chance at winning the Motorcycle Prize. Sponsor will randomly select and award the potential Motorcycle Prize to one (1) of the confirmed Grand Prize winners on or around March 12, 2022 at the Event (location: Destination Daytona Complex with an address of 637 US-1, Ormond Beach, FL 32174). If the potential Motorcycle Prize winner fails to provide any other requested information within the required time period (if applicable), the potential Motorcycle Prize winner forfeits his/her/their prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that the potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the Motorcycle Prize to an alternate confirmed Grand Prize winner by random drawing. Only three (3) alternate drawings will be held, after which the Motorcycle Prize will remain un-awarded.
